### **BAND vs. CRIMP**

Hose assembly pressure ratings are limited by coupling attachment methodology.

Industrial hose applications become more demanding every day. New rubber compounds, higher working pressures and temperatures, and stricter environmental and safety regulations all make hose and coupling selection a challenge.

The traditional industry practice of mixing and matching hoses and fittings from different manufacturers carries greater risk than ever. Poor quality or incorrectly fabricated hose assemblies can cause equipment damage, lost productivity, personal injury, or worse.

Gates GC®96 Crimper with horizontal front-end feed makes crimping fast, easy, and accurate.



Assemblies are tested and verified to meet applicable industry standards for any given application.

### PRECISION CRIMPED ASSEMBLIES - 1/4 TO 6-INCH HOSE SIZES

Gates Authorized E2E distributors are trained at the Gates Customer Solutions Center and are certified in our Industrial Hose workshops following the NAHAD fabrication procedures.



The Gates GC®96 Crimper can produce crimped assemblies on 1/4" – 6" ID industrial hoses. The crimper accepts Gates one-piece GLX coupling for an exact hose-to-coupling match. The latest specifications can be downloaded via the crimper's touchpad from Gates online eCrimp program, always ensuring a precise assembly. The resulting crimped assemblies generally outperform banded or clamped assemblies.

### **TESTING AND CERTIFICATION**

To ensure crimp integrity and reliability, assemblies are tested to the rated proof pressure of the hose and accompanied by test certificates. Additional hydrostatic testing or electrical conductivity testing may be carried out as required. Testing is done in accordance with ARPM [Association for Rubber Products Manufacturers] recommended methods.
